Members' Business motions that have not achieved cross party support

*S6M-14784 Clare Adamson: Pancreatic Cancer Awareness Month and World Pancreatic Cancer Day 2024—That the Parliament marks Pancreatic Cancer Awareness Month, which takes place every November, and World Pancreatic Cancer Day, which takes place on 21 November 2024; believes that, for decades, pancreatic cancer has been left behind, receiving just 3% of the UK cancer research budget; considers that an increase in long-term investment in such research could transform persistent low survival rates; welcomes Pancreatic Cancer UK's recent announcement of nearly £600,000 in funding for research taking place in Scotland into early diagnosis and treatment for the disease; acknowledges that pancreatic cancer is tough to detect and diagnose and understands that, once diagnosed, only three out of 10 people get any treatment, the lowest proportion of all cancer types; acknowledges that half of people die within three months of diagnosis; believes that, once diagnosed, people often face obstacles getting the information and care that they need to be well enough to have treatment, with scarce patient experience data and many people feeling "written off", with no support plan in place or help to manage symptoms; understands that, at present, there are shortages in the availability of pancreatic enzyme replacement therapy (PERT), directly affecting the quality of life for people living with pancreatic cancer and other conditions; commends the health professionals and pancreatic cancer charities coming together to develop holistic support and guidance on what to do if a patient is running low or cannot get PERT; further commends all of the charities and activist organisations, and their dedicated supporters, on what it sees as their tireless efforts to improve outcomes for people with this condition, and wishes everyone involved with Pancreatic Cancer Awareness Month and World Pancreatic Cancer Day every success in raising awareness of this devastating disease.

carried out by MSPs, who took written and oral evidence from a wide section of witnesses, including breweries, pub operators, trade groups and research organisations; understands that witnesses told the inquiry about the dynamic and vibrant contribution that the sector makes to communities and the economy across Scotland, including in the South Scotland region, with over 100 breweries and 4,340 pubs employing 65,000 people and contributing £1.8 billion in wider economic benefits; notes what it sees as the largely unacknowledged and unique benefits that Scotland's pubs and breweries provide, including preventing social exclusion, boosting tourism, supporting local festivals, music, arts and sport, and acting as a catalyst for local events and charity fundraising; further notes, with concern, reports that Scotland's pubs are closing at a faster rate than elsewhere in the UK, with investment being diverted as, it understands, a lack of certainty makes it difficult to plan ahead, including as a result of regulatory proposals, complex and time consuming planning processes, employment challenges and business rates; notes that the report calls for a new hospitality strategy that aligns with Brand Scotland, which includes a review of business rates, the promotion of employment opportunities and a recognition of the need for a period of regulatory calm, and which should be developed in partnership with the sector, trade representatives and the Scottish Government, and further notes the calls for MSPs to commit to implementing these changes for the social and economic wellbeing of the Scottish hospitality sector.

*S6M-14797 Sandesh Gulhane: Professor Sir Jim McDonald Announces Retirement as Principal and Vice-Chancellor of the University of Strathclyde —That the Parliament notes that Professor Sir Jim McDonald has announced that he will retire as Principal and Vice-Chancellor of the University of Strathclyde in August 2025, after 16 years in the post; believes that, in this time, he has developed the university as a leading international technological centre, increased its research income by 350%, overseen a £1 billion campus redevelopment and widened access to the institution, as well as helped in the establishment of two innovation districts, with the Glasgow City Innovation District and the Advanced Manufacturing Innovation District; notes that, in addition, under his leadership, the University of Strathclyde has been recognised with several awards, including being the only institution to be named *Times Higher Education* UK University of the Year twice and receive three consecutive Queens Anniversary Prizes; congratulates Professor Sir Jim McDonald on his numerous achievements in the role, thanks him for his service and wishes him well, and looks forward to the University of Strathclyde continuing to flourish in the future.

The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no statement is made that the Scottish Government is planning equivalent legislation.
