# FREQUENTLY ASKED QUESTIONS FOR: THE (NEW) BUSINESS BULLETIN (BB) – WEB VERSION

#### Q. Why are we changing the BB

In order to meet the growing demands of Members and the wider society to access information anytime anywhere, we needed to produce parliamentary business information and services fit for digital consumption. The Business Bulletin (BB) is a key Parliamentary document and thus the BB production process has been transformed to deliver the BB digitally and the Digital and Printed outputs have been transformed to engage the consumer both visually and functionally. The new digital Bulletin contains new features, such as the ability to share information contained within the Bulletin via email and direct to social media, and to filter motions and questions by type and by party or group.

#### Q. What has changed in the new web version of the Business Bulletin?

• The first thing you will notice is that there are no "Section A, B, C..." headings – these different sections are now simply recognised by their titles and these are shown in square tiles, horizontally across the top of the Home page.




Next is the Today's Business Calendar strip which allows you to select the day's business you wish to view, for both Parliament
Business and Committee Business. This calendar only shows today and future days. You can use the arrow buttons to change the
week or click on the small calendar image in the top left of the date window which to access a full monthly calendar enabling you to
select a specific date.





- When you click on the Business Calendar tile, Today's Business will be detailed under separate tabs for Parliament Business and Committee Business.
- Future Business can be found by selecting the desired date on the calendar strip.
- All **Motions** and **Questions** can be found by clicking on the respective new tiles, positioned under the BB tile at the top of the screen.
- Similarly, all items relating to **Legislation** (including New Bills & Accompanying Documents, Amendments, Members' Bills Proposals, New Subordinate Legislation and Progress of Legislation) can be found by clicking on the Legislation tile.
- The **Other** tile contains Petitions information, New Documents, Corrections and the Contacts page.
- A new feature allows you to save specific items of interest in the BB to a **Favourites** folder. Please note that the contents expire when you close the browser window at the end of each browser session. This feature will be available in a future release of the web version of the Business Bulletin.

## Q. Has anything been removed in the new web version of the BB?

Yes, there are two items that have been removed:

- 1. Past issues of the Business Bulletin are not available in the first "Beta" version of the new website, but will be accessible via an **Archive** link in the near future.
- 2. There are two symbols that are no longer being printed next to motions to identify them; they are no longer required as the motions are now being printed in categories which negate the need for the symbols. Those symbols are:
  - a. # which was used to identify Members' Business motions that had received the required level of cross-party support
  - b. ♦ which was used to identify Members' Business motions that had not yet received the required level of cross-party support

### Q. Will there still be a 'Today's Business' section available for me to print from the website?

There is no specific "Today's Business" PDF to print off, but you can still print out the entire BB or individual pages as required.
